



## VCAS ROUND 4 SATURDAY 11<sup>th</sup> JUNE and SUNDAY 12<sup>th</sup> JUNE 2016 SUPPLEMENTARY REGULATIONS

### 1. THE EVENT

The event, a Multi-Club Autocross, shall be known as Round 4 of the Victorian Club Autocross Series (VCAS) and will hereafter be called the event. The event will be a timed autocross for holders of a current car club membership with CAMS affiliated car clubs. The event will consist of 2 portions – Competitors may enter either or both portions of the event.

### 6. AUTHORITY

The event will be held under the International Sporting Code of the FIA, the National Competition Rules (NCR) of the Confederation of Australian Motor Sport Ltd. (CAMS), the Speed Event Standing Regulations, Autocross Standing Regulations, the Passenger in Vehicle Guidelines VCAS Standing Regulations, the CAMS Victoria NGK Junior Pentathlon Series 2016 Regulations, these Supplementary Regulations and any Further Regulations which may be issued. The event will be held under and in accordance with the CAMS OH&S and Risk Management Policies, which can be found at [www.cams.com.au](http://www.cams.com.au)

### 7. PLACE AND DATE

The event will be held at the Jack Chisholm Reserve approx. 10km west of Swan Hill on the Sea Lake – Swan Hill Road, Swan Hill (see instructions)

SATURDAY 11<sup>th</sup> JUNE 2016 - VCAS portion of the event- Scrutineering will commence at 11.30am. Drivers briefing will be at 12.45pm followed by a parade lap on both tracks. Official runs will commence at 1.00pm.

SUNDAY 12<sup>th</sup> JUNE 2016 - Practice portion of the event. Scrutineering to start at 9.00am and Official runs will start at 10.00am.

### 8. ENTRIES

(a) Entries will open on the publication of these Supp Regs and close at 10.00AM on 11<sup>th</sup> JUNE. Entries are to be sent to the Event Secretary, with the correct entry fee. Cheques or money orders should be made to “Secretary – Swan Hill Sporting Car Club” or “SHSCC Inc” and posted to PO Box 691 Swan Hill 3585.

Entry Fees can also be paid by Direct Deposit into the SHSCC Bank Account up until Thursday 8<sup>th</sup> JUNE. Please use your first and surname as a Reference on your email/entry form if you choose to pay this way.

- (b) The entry fee for entries submitted at or before 9:00pm Wednesday 7<sup>th</sup> June shall be:  
VCAS round Saturday Only: \$55 for drivers aged 18 or over, and \$35 for drivers aged less than 18  
Sunday Practice Only: \$40 for drivers aged 18 or over, and \$35 for drivers aged less than 18  
Saturday and Sunday: \$90 for drivers aged 18 or over, and \$65 for drivers aged less than 18.
- (c) For entries (including the Saturday portion of the event) after the early closing date an additional fee of \$30.00 may apply. An entry will only be deemed valid when payment is received with a signed entry form.
- (d) There will be a maximum of four drivers per vehicle
- (e) Series Entry Drivers who have completed their Series Entry Form at least 2 weeks prior to the event have their place reserved by the organizers until 5.00pm Friday 27<sup>th</sup> May. If no entry is received by a Series Entry Driver by this date, their reserved entry is forfeited.
- (f) A maximum of 100 entries will be accepted, in order of receipt (Excepting Series Entered Drivers).
- (g) The promoter reserves the right to refuse an entry in accordance with NCR 83.

## 9. INSURANCE

- (a) Certain public, property, professional indemnity and personal accident insurance is provided by CAMS in relation to the event. Further details can be found in the CAMS Insurance Handbook, available at [www.cams.com.au](http://www.cams.com.au).
- (b) Passengers will allowed on SUNDAY ONLY-12<sup>th</sup> June aged 14 plus

## 10. CLASSES (Drivers will be graded into the following classes)

- P Standard Production (2WD, Road Tyres Only, No Driveline Modifications allowed)  
C 0-1600cc Modified (2WD, No Firewall Modifications, Similar Engine Only (Make & No of cyl)  
D 1601-2000cc Modified (2WD, No Firewall Modifications, Similar Engine Only (Make & No of cyl)  
E Over 2000cc Modified (2WD, No Firewall Modifications, Similar Engine Only (Make & No of cyl)  
J Juniors – Aged 14 -18yo as of 1<sup>st</sup> January 2016 (Restrictions apply refer VCAS 2015 Standing Regulations)  
L Ladies (Restrictions apply refer VCAS 2016 Standing Regulations)  
S Specials (Custom built cars and excessively modified sedans)  
W Production Based 4WD or AWD (no tyre restrictions apply)

## 11. STARTING ORDER

Lining up on grid, with preference given to those who have not completed enough runs.

## 12. DRIVERS

- (a) All drivers must hold and present a CAMS level 2S License or superior and a current membership card for a CAMS affiliated car club. If issued, CAMS Vehicle Logbook must be presented.
- (b) All competitors are required to wear snug fitting clothes covering the body from neck to wrist to ankles and suitable footwear. Clothing should be of a FIRE RESISTANT NATURE. All apparel, including helmets must comply with the requirements of Schedule D of the current CAMS Manual of Motor Sport.
- (c) The organizers reserve the right to refuse any entry or if deemed appropriate, the Clerk of Course may withdraw any entry on the grounds of safety, misconduct or inappropriate behavior.

## 13. COURSE

The event will be run over twin 1.9km (approx) courses of dirt defined by tyres, witches hats and bunting. All runs will be a single lap timed from a standing start. Drivers will be expected to compete upon both the twin tracks to complete the event.

## 14. VEHICLE ELIGIBILITY

Vehicles must conform to the VCAS series regulations including but not limited to:

- (a) Vehicles must conform with the General Requirements for Cars and Drivers (Schedules A and B of the current CAMS Manual of Motor Sport). All vehicles must be fitted with a suitable front and back towing hook.
- (b) All vehicles must be fitted with two separate fastening systems on any opening front panel in accordance with Schedule B.
- (c) Fire extinguishers to a standard listed in Schedule H of the CAMS Manual of Motor Sport must be securely fitted to the vehicle. As per current regulations **Each AS1841 standard fire extinguisher shall be serviced every three years.**
- (d) All vehicles (except road registered vehicles) in Class A or B must be fitted with mud flaps on all driven wheels and on both rear wheels. All vehicles must have mudguards covering all road wheels
- (e) Any vehicles competing in Class S must be fitted with rollover protection as outlined in Schedule J. Rollover protection is highly recommended in all other cases.
- (f) Fuel shall be in accordance with Schedule G of the current CAMS Manual of Motor Sport.

(g) Tyres as per CAMS Standing Regulations

## **15. RUNNING DETAIL**

VCAS results will be determined by the competitors fastest 2 laps for each of the twin courses to be run (ie each driver must compete on each course a minimum of twice – which is the drivers responsibility to achieve). The number of runs will be determined by the Clerk of Course, dependent on the condition of the track. Timing will be controlled by electronic light beams, with hand held stopwatches as back up. Timekeepers are deemed Judge of Fact.

## **16. STARTING PROCEDURE**

Pairs of competitors will line up in numerical order and will be moved onto the starting pads immediately after the previous pair of competitors has departed. The starter will indicate to the drivers when to proceed onto the course. Any competitor who encounters difficulties on the course will be permitted a re-run only at the discretion of the Clerk of Course. (*Reruns are usually given only to competitors whose runs were cancelled due to an on track issue or mistimed*)

## **17. FINISH PROCEDURE**

At the end of each run the driver on the inside track is to give way to the driver on the outside track. The driver on the inner course MUST adhere to this at all times. All times when moving within the pit area and leaving the autocross area, the maximum speed limit is to be walking pace.

## **18. TERMINATION**

The organisers reserve the right to stop the event at any time if they consider it necessary, in the interests of safety or for any other reason.

## **19. POSTPONEMENTS OR ABANDONMENT**

The organisers reserve the right to postpone, abandon, or cancel the event in accordance with NCR 59, or if insufficient entries are received. If the event is cancelled or postponed for more than 24 hours, the entry fees shall be refunded in full.

## **20. AWARDS**

Trophies will be presented to the following drivers

\* 1<sup>st</sup>, 2<sup>nd</sup>, 3<sup>rd</sup> outright

\* 1<sup>st</sup> in each class (2 or more entries in class)

\*2<sup>nd</sup> in each class (>5 entries in class)

\*3<sup>rd</sup> in each class (>10 entries in class)

## **21. ANTI DOPING POLICY**

### **ALCOHOL, DRUGS AND OTHER SUBSTANCES**

Any holder of a CAMS 'Competition' or 'Officials' licence (or equivalent licence issued by another ASN) may be tested for the presence of drugs (or other banned substances) and subject to a penalty(ies) for a breach in accordance with the CAMS Anti-Doping Policy and/or the CAMS Illicit Drugs in Sport (Safety Testing) Policy as published on the CAMS website. Consumption of alcohol in the paddock, pits or any section of the competition venue/course under the control of the Officials is forbidden until all competition is concluded each day. Accordingly, any holder of a CAMS 'Competition' or 'Officials' licence (or equivalent licence issued by another ASN) may also be tested for the presence of alcohol by a CAMS Accredited Testing Official (CATO) in accordance with the CAMS Standard Operating Procedure for Breath Alcohol Testing.

## **22. NOISE**

Vehicles must not exceed a noise limit of 95dB (A).

## **23. PENALTIES**

(a) Shortening the course- 10 seconds per instance or run not counted.

Dislodging penalty markers- 5 seconds per instance

(b) Timekeepers, Infield Officials and the Clerk of Course or his nominee are deemed will be Judges of Fact with respect to penalties

(c) Penalties shall be applied as described in the current VCAS Series Regulation

(b) Any breach of these Supplementary Regulations will be dealt with in the same manner as breaches of all other regulations pertaining to the event

## 24. PROTESTS

Protests must be lodged in accordance with Part XII of the NCR and accompanied by the appropriate fee.

## 25. FURTHER REGULATIONS.

The organizers reserve the right to issue competitors with Further Regulations. Such regulations will have the same authority as these regulations.

## 26. RESULTS.

The organizers will supply results to all competitors via either email (if supplied) or via mail, with results also to be posted on the VCAS egroup to be found at [http://sports.groups.yahoo.com/group/VCAS\\_Autocross/](http://sports.groups.yahoo.com/group/VCAS_Autocross/)

## 27. CATERING.

Food and refreshment will be available from the Catering area near the SHSCC clubhouse on the days and evening of the event.

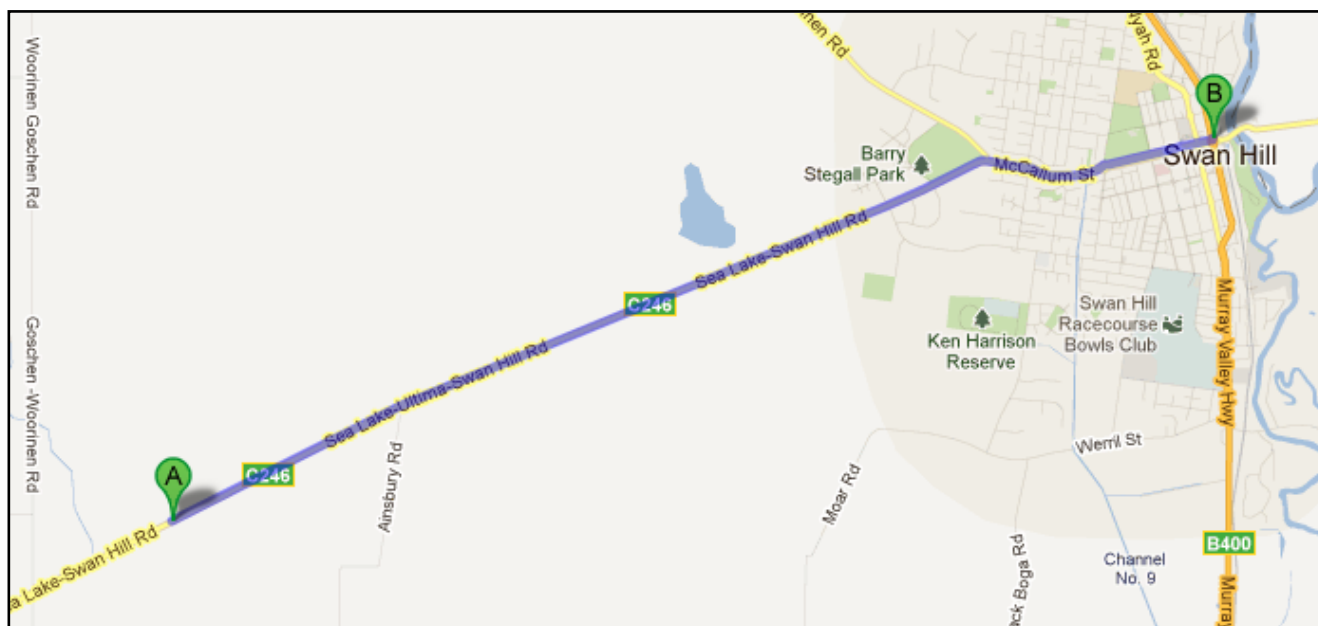

- Continue On McCallum Street past the football oval in town, and new suburbs at the edge of town and continue on this route towards Sea Lake (Road name changes on the outskirts of town to Sea Lake – Swan Hill Road) – The Track is approx. 9.2km from the Murray Valley Highway Clock Tower and on the left (south side) of the road in the Jack Chisholm Reserve. Just follow the road down to the back past the Speedway.
