



ROUND5 SATURDAY 8th June and Sunday 9th June SUPPLEMENTARY REGULATIONS

1. THE EVENT

The event, a Multi-Club Autocross, shall be known as Round 5 of the Victorian Club Autocross Series (VCAS) and will hereafter be called the event. The event will be a timed autocross for holders of a current car club membership with CAMS affiliated car clubs. The event will consist of 2 portions – Competitors may enter either or both portions of the event.

2. PROMOTERS

6. AUTHORITY

The event will be held under the International Sporting code of the FIA, the National Competition Rules (NCR) of the Confederation of Australian Motor Sport Ltd. (CAMS), the Speed Event, Autocross & VCAS Standing Regulations, the CAMS Victoria NGK Junior Pentathlon Series 2013 regulations, these Supplementary Regulations and any Further Regulations which may be issued. The event will be held under and in accordance with the CAMS OH&S and Risk Management Policies, which can be found at www.cams.com.au

7. PLACE AND DATE

The event will be held at the Jack Chisholm Reserve approx. 10km west of Swan Hill on the Sea Lake – Swan Hill Road, Swan Hill (see instructions)

SATURDAY 8th JUNE 2013 - **VCAS portion of the event**- in twilight conditions. Scrutineering will commence at 11am. Drivers briefing will be at 12.noon followed by a parade lap. Official runs will commence at 12.15pm and are expected to finish around 9 - 10pm.

SUNDAY 9th JUNE 2013 - **Practice portion of the event**. Scrutineering to start at 7.00am and Official runs will start at 8.00am. Completion will be at 2.00pm.

8. ENTRIES

- (a) Entries will open on the publication of these regulations and close at 11:45am on 8TH June 2013. Entries are to be sent to the Event Secretary, with the correct entry fee. Cheques or money orders should be made to "Secretary – Swan Hill Sporting Car Club" or "SHSCC Inc" and posted or delivered to PO Box 691 Swan Hill 3585.
- (b) The entry fee for entries submitted at or before 9:00pm Wednesday 5th June shall be:

- (c) For entries (including the Saturday portion of the event) after the early closing date an additional fee of \$30.00 will apply. An entry will only be deemed valid when payment is received with a signed entry form.
- (d) There will be a maximum of four drivers per vehicle
- (e) Series Entry Drivers who have completed their Series Entry Form at least 2 weeks prior to the event have their place reserved by the organizers until 5.00pm Friday 31st May 2013. If no entry is received by a Series Entry Driver by this date, their reserved entry is forfeited.
- (f) A maximum of 80 entries will be accepted, in order of receipt (Excepting Series Entered Drivers).
- (g) The promoter reserves the right to refuse an entry in accordance with NCR 83 of the current CAMS Manual.

9. INSURANCE

- (a) Public risk insurance has been effected by the Promoters.
- (b) All drivers and officials are covered by the motorsport personal accident policy.
- (c) For further details, refer to Appendix I of the current CAMS Manual of Motorsport.

10. CLASSES (Drivers will be graded into the following classes)

- A 0-2000cc Standard (2WD, Road Tyres Only, No Driveline Modifications Allowed)
- B Over 2000cc Standard (2WD, Road Tyres Only, No Driveline Modifications Allowed)
- C 0-1600cc Modified (2WD, No Firewall Modifications, Similar Engine Only (Make & No of cyl)
- D 1601-2000cc Modified (2WD, No Firewall Modifications, Similar Engine Only (Make & No of cyl)
- E Over 2000cc Modified (2WD, No Firewall Modifications, Similar Engine Only (Make & No of cyl)
- J Juniors – Aged 14 -18yo as of 1st January 2013
- L Ladies
- S Specials (Custom built cars and excessively modified sedans)
- W Production Based 4WD or AWD (no tyre restrictions apply)

11. STARTING ORDER

Will be in numerical order with the first class as per VCAS Standing Regulations. (Different class starts each round) Starting order within each class will be determined by the order of receipt of entry, with drivers of shared vehicles suitably spaced to allow changeovers with minimal disruption to the event

12. DRIVERS

- (a) All drivers must hold and present a CAMS level 2S/2SJ License or superior and a current membership card for a CAMS affiliated car club.
- (b) All competitors are required to wear snug fitting clothes covering the body from neck to wrist to ankles and suitable footwear. Clothing should be of a fire resistant nature. All apparel, including helmets must comply with the requirements of Schedule D of the current CAMS Manual of Motor Sport.
- (c) The organizers reserve the right to refuse any entry or if deemed appropriate, the Clerk of Course may withdraw any entry on the grounds of safety, misconduct or inappropriate behavior.

13. COURSE

The event will be run over twin 1.6km (approx) courses of dirt defined by tyres, witches hats and bunting. All runs will be a single lap timed from a standing start. Drivers will be expected to compete upon both the twin tracks to complete the event.

14. VEHICLE ELIGIBILITY

- (a) Vehicles must conform with the General Requirements for Cars and Drivers (Schedules A and B of the current CAMS manual). All vehicles must be fitted with a suitable front and back towing hook.
- (b) All vehicles must be fitted with two separate fastening systems on any opening front panel in accordance with Schedule B of the current CAMS Manual.
- (c) Fire extinguishers to a standard listed in Schedule H of the current CAMS Manual must be securely fitted to the vehicle. (*Dated or rechecked within 3 years of the date of the event*)
- (d) All vehicles (except road registered vehicles in class A or B) must be fitted with mud flaps on all driven wheels and on both rear wheels. All vehicles must have mudguards covering all road wheels
- (e) Any vehicles competing in Class S must be fitted with rollover protection as outlined in Schedule J of the current CAMS Manual. Rollover protection is highly recommended in all other cases
- (f) All vehicles must comply with VCAS 2013 Series Rules 6.7 or 6.8
- (g) Fuel must comply with Schedule G of the current CAMS Manual.

15. RUNNING DETAIL

VCAS results will be determined by the competitors fastest 2 laps for each of the twin courses to be run (ie each driver must compete on each course a minimum of twice – which is the drivers responsibility to achieve). The number of

runs will be determined by the Clerk of Course, dependent on the condition of the track. Timing will be controlled by electronic light beams, with hand held stopwatches as back up. Timekeepers are deemed Judge of Fact.

16. STARTING PROCEDURE

Pairs of competitors will line up in numerical order and will be moved onto the starting pads immediately after the previous pair of competitors has departed. The starter will indicate to the drivers when to proceed onto the course. Any competitor who encounters difficulties on the course will be permitted a re-run only at the discretion of the Clerk of Course. (*Reruns are usually given only to competitors whose runs were cancelled due to an on track issue or mistimed*)

17. FINISH PROCEDURE

At the end of each run the driver is to immediately decelerate the vehicle stop on their track. They are only to proceed to the pit area from the competition area when directed by the starter (the driver on the inner course **MUST** adhere to this at all times). At all times when moving within the pit area and leaving the autocross area, the maximum speed limit is to be 10kph.

18. TERMINATION

The organisers reserve the right to stop the event at any time if they consider it necessary, in the interests of safety or for any other reason.

19. POSTPONEMENTS OR ABANDONMENT

The organisers reserve the right to postpone, abandon, or cancel the event, or if insufficient entries are received in accordance with NCR 59 of the current CAMS Manual. If the event is cancelled or postponed for more than 24 hours, the entry fees shall be refunded in full.

20. AWARDS

Trophies will be presented to the following drivers

- 1st, 2nd, and 3rd Outright and 1st in each class
- 2nd in each class (where there are >5 entries in class) and 3rd in each class (where there are >10 entries in class)

21. ANTI DOPING POLICY

Use of prohibited Substances

During any event, consumption of alcoholic beverages in the paddock, pits or any other portion of the competition venue under the control of the officials is expressly forbidden until all practice or competition activity is concluded for each day. Any driver or crew member who is found to be affected by alcohol on the day of the event or practice therefore shall not be permitted to participate. Refer NCR 145A of the Current CAMS Manual. In addition, the persons concerned will be subject to the Articles of the Standard Operating Procedure for Alcohol Testing and CAMS Anti-Doping Policy. Competitors, crews or officials may be randomly tested for alcohol by a CAMS Accredited Testing Official (CATO) or other drugs at any time during the event(s).

Other Prohibited Substances

The CAMS Anti Doping Policy, as appears in the CAMS Manual of Motor Sport and as amended from time to time, is recognised as an integral component of the NCR and is duly authorised as such. In any areas where the National Competition Rules and the CAMS Anti Doping Policy conflict, the CAMS Anti Doping Policy will take precedence.

22. NOISE

Vehicles must not exceed a noise limit of 95dB (A).

23. PENALTIES

- (a) Shortening the course - 10 seconds per instance or run not counted.
Dislodging penalty markers - 5 seconds per instance.
- (b) Any breach of these Supplementary Regulations will be dealt with in the same manner as breaches of all other regulations pertaining to the event
- (c) Timekeepers, Infield Officials and the Clerk of Course or his nominee are deemed will be Judges of Fact with respect to penalties

24. PROTESTS

Protests must be lodged in accordance with Part XII of the current CAMS Manual and accompanied by the appropriate fee.

25. FURTHER REGULATIONS.

The organizers reserve the right to issue competitors with further regulations. Such regulations will have the same authority as these regulations.

26. RESULTS.

The organizers will supply results to all competitors via either email (if supplied) or via mail, with results also to be posted on the VCAS egroup to be found at http://sports.groups.yahoo.com/group/VCAS_Autocross/

27. CATERING.

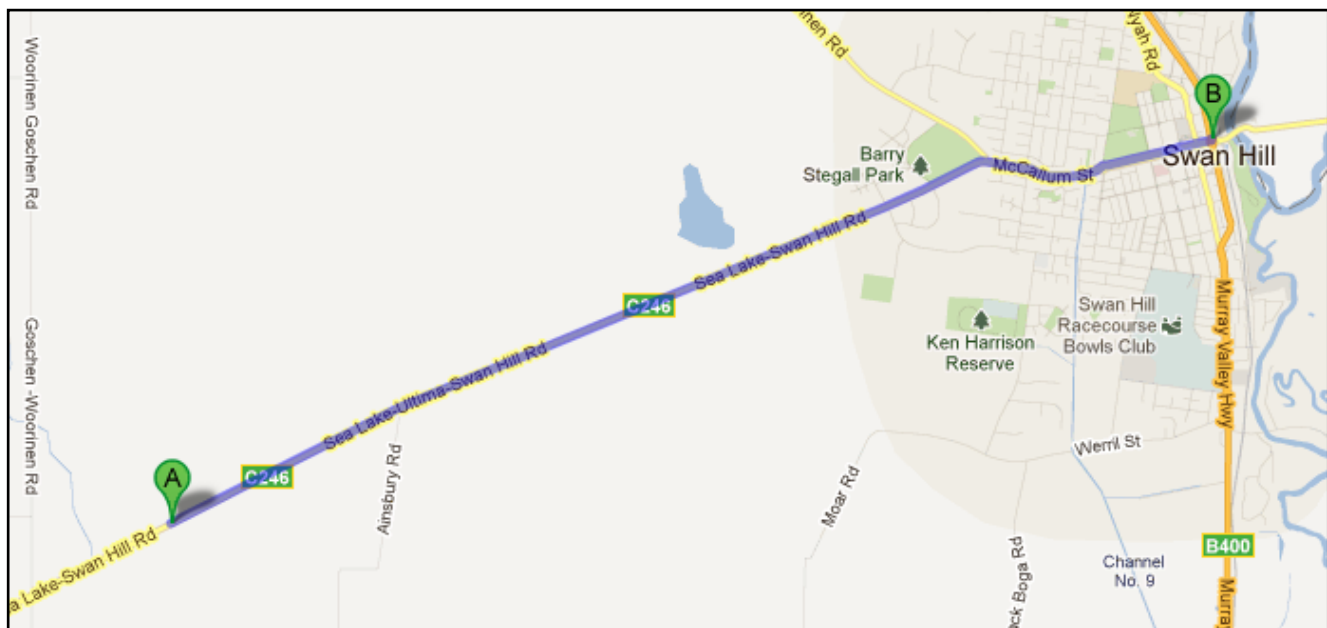
Food and refreshment will be available from the Catering area near the SHSCC clubhouse on the days and evening of the event.
